PRIVACY POLICY OF ZDROJOWAHOTELS.PL

This document describes the rules for the processing of the Users' personal data collected by the Website, including the procedure concerning the use of cookie files. As regards cases connected with personal data protection at Zdrojowa Hotels Sp. z o.o. you can get in touch with our Personal Data Officer, who is available at the following e-mail address: iod@zdrojowainvest.pl or to the address Zdrojowa Hotels Sp. z o.o., with the "IOD" annotation on the envelope.

1. What is what, i.e. explanation of the meaning of certain words we use in the Privacy Policy.

- 1.1. "Zdrojowa Hotels" (or "we", "us") i.e. us, the owners of the website available at the address zdrojowahotels.pl, and specifically Zdrojowa Hotels Sp. z o.o. with its registered office in Kołobrzeg, ul. Antoniego Sułkowskiego 9, 78-100 Kołobrzeg, entered in the register of entrepreneurs kept by the District Court in Koszalin, 9th Division of the National Court Register under KRS number 0000296672, share capital of PLN 22 500 000, REGON: 320441334, NIP: 6711756876
- 1.2. "User" (or "you", or any other personal form in which we address you) internet user who visits zdrojowahotels.pl (and its web pages), i.e. the Website, or Zdrojowa Hotels Fanpage in social media.
- 1.3. "Privacy Policy" this document.
- $\textbf{1.4.} \ "Website"-website available at the address zdrojowahotels.pl.$
- 1.5. "Services" Website's functionalities which we make available to you, e.g. the possibility of booking a hotel room, opening an account. Certain services are available only to those persons who have created the account.
- 1.6. "Cookies" IT data, in particular text files, which are stored on the User's end device which help use the Website's web pages. Cookies usually contain the name of the web page from which they originate, time for which they are stored at the end device and a unique ID number.
- 1.7. "Personal data" means the information which on its own or in combination with other information allow your identification, in particular by reference to such data as the name, surname, ID number, localisation data, network ID.
- **1.8.** "Zdrojowa Hotels Fanpage" web pages, accounts, channels conducted by Zdrojowa Hotels in such social media, as: Facebook, Instagram, YouTube Twitter
- 1.9. "GDPR" Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation).
- **1.10.** "Hotel" hotels in which it is possible to book a stay through the Website and which are operated by various companies from Zdrojowa Hotels Group.
- 1.11. "Zdrojowa Hotels Group" operators of the individual hotels in which you can make a booking through the Website, i.e.

2. Who is the controller of your personal data?

- 2.1. The controller of your personal data is Zdrojowa Hotels Sp. z o.o., with its registered office in Kołobrzeg, ul. Antoniego Sułkowskiego 9, 78-100 Kołobrzeg, entered in the register of entrepreneurs kept by the District Court in Koszalin, 9th Division of the National Court Register under KRS number 0000296672, share capital of PLN 22 500 000, REGON: 320441334, NIP: 6711756876, e-mail: sekretariat@zdrojowahotels.pl
- **2.2.** As we have mentioned in the beginning, in order to secure your personal data we have designated the Persona Data Officer you can get in touch with the fastest at the following e-mail address: iod@zdrojowainvest.pl. You can also send a traditional letter to our address, but remember to add the "IOD" annotation.
- **2.3.** Zdrojowa Hotels uses technical and organisational measures aimed at securing the personal data we receive in compliance with the regulations resulting from applicable legal regulations.
- **2.4.** Before being granted access to the processing of personal data, each person we employ or cooperate with is obliged to keep the personal data confidential. That secret also covers any information concerning the manners in which the personal data entrusted for processing are protected.

3. For what purposes we use your personal data?

3.1. The purpose of processing of personal data by Zdrojowa Hotels is determined by the services we render to the User. Below we have indicated the purposes of processing, as well as the situations in which data are processed. At the same time, we have indicated the legal basis and the period of retention of personal data (data processing period).

4. Who we make your personal data available to?

- **4.1.** Personal data are disclosed to the companies from Zdrojowa Hotels Group to the extent to which it is necessary to achieve the purpose of the processing of personal data, e.g. booking a stay at a hotel operated by another company than Zdrojowa Hotels.
- **4.2.** Furthermore, personal data are disclosed to entities which support us on the basis of the services commissioned to them and the processing agreements entered into with them. They also include companies which provide us with certain services in the area of IT and marketing (Benhauer sp. z o.o., ul. Grzegórzecka 21, 31-532 Kraków), communication (LiveCall Software sp. z o.o., ul. Międzynarodowa 55/3, 03-922 Warszawa), which archive and destroy data media, which support us in the legal area, as well as courier companies.
- **4.3.** The transaction data, including the personal data you provide while making payments, are processed by Elavon Financial Services Designated Activity Company (limited liability company with indicated object of economic activity) Branch in Poland, with its registered office in Warsaw, ul. Puławska 17, 02-515 Warszawa.
- **4.4.** In the cases required by generally applicable legal regulations, we reserve the right to make the data available to public administration offices and bodies authorised to process personal data, e.g. law enforcement bodies or courts.

5. What are your rights in the context of your personal data?

Each User has:

- 5.1. The right of access to their personal data (Article 15 GDPR), including the right to obtain a copy of the data (Article 15 (3) GDPR),
- 5.2. The right to rectify (correct) or supplement incomplete personal data (Article 16 GDPR).
- 5.3. The right to demand that their personal data are deleted in the cases provided for by law (Article 17 GDPR).
- **5.4.** The right to make a request for restriction of the processing of personal data (Article 18 GDPR).
- **5.5.** The right to receive their personal data in a structured and generally used format and to transfer them when the processing takes place on the basis of consent or an agreement, and when the processing is performed in an automated manner (Article 20 GDPR).
- **5.6.** The right to object to the processing of personal data if they are processed in order to pursue controller's legitimate interest due to reasons connected with their particular situation, including to profiling (Article 21 GDPR).
- **5.7.** In the cases in which the processing of data takes place on the basis of a separate consent, you have the right to withdraw the consent given at any time, but it will not affect the lawfulness of the processing prior to the withdrawal. The consent can be withdrawn through e-mail contact: iod@zdrojowainvest.pl.
- **5.8.** If the User comes to the conclusion that the processing of personal data is in breach of the GDPR provisions he has the right to lodge a complaint with the supervisory authority, i.e. to the President of the Personal Data Protection Office with its seat in Warsaw at ul. Stawki 2,

- **5.9.** Provision of personal data is voluntary, but in certain situations it is a statutory or contractual requirement, and, consequently, failure to provide them will make it impossible to comply with a legal regulation or to entering into and properly perform the agreement.

which may involve processing User's personal data by us when the User visits the above-mentioned profiles, sites and channels, or interacts with those profiles, sites and channels (likes, subscriptions, comments, messages sent). If the User visits our profiles in such portals as Facebook and Instagram, the data collected concern the User's activity on such a profile, including likes, messages sent to us, comments' content and posts placed on that profile. In such a case, one should remember that, being users of social networking sites, the User and Zdrojowa Hotels are also bound by the privacy policy and regulations accepted as part of that site. The data connected with the User's activity as part of our social media profiles will be stored until the User removes them or they are removed by us or by the owner of a given social networking site. One should also remember that being a user of each of the social networking sites where we have our profile, the User can also manage his account and the content published in accordance with that site's regulations.

7. Cookie files

- 7.1. We would like to inform you that as part of the Website we use the following types of cookie files:
- strictly necessary cookies (e.g. for logging in to the account),
- session cookies (e.g. tokens securing forms),
- external cookies (Google Analitycs, Google Tag Manager, Adwords, etc.).
- **7.2.** We also use cookies for marketing purposes:
- User targeting, i.e. selection of users in order to determine the target group which, to the greatest extent, is interested in ads of our hotel and being redirected to the Website,
- · User retargeting, i.e. showing a Zdrojowa Hotels ad only to those Users who have already visited our target site (Website),
- creating lookalike profiles, i.e. looking for Users who are similar to our Users by using information and knowledge about them by means of relevant algorithms, in order to find their "twins", i.e. look for such Users who are as similar to them as possible in terms of interests, behaviour and intentions.
- analysing and reporting effectiveness of advertising campaigns.
- **7.3.** We would like to inform you that the Website collects only the information included in the cookie files which can be combined with personal data, e.g. data provided during the account registration / booking stay at a hotel.
- 7.4. Furthermore, we would like to inform you that, apart from the above-mentioned purposes, cookie files are used for the following purposes:
- adapting the Website's content to your preferences and optimisation of the way in which the web pages are used. In particular, the files help recognise the User's device and properly display the web page adapted to his individual needs,
- keeping the User's session (if he is logged), which means that the User does not have to log on each subsite of the Website,
- creating statistics which are the basis for analysis how Users use Website's web pages,
- displaying Zdrojowa Hotels ads also on other web pages outside the Website,
- building the User profile on the basis of his decisions and activity,

- **7.5.** Please remember that the software for browsing websites (internet browser) may allow, by default, storing cookies on the User's end device. Users can, at any time, change the cookie file settings, e.g. in such a way that they block automatic cookie handling in the internet browser's settings, or inform Users each time they have been placed on the User's end device.
- **7.6.** Detailed information on the possibilities and ways of managing cookies is available in the internet browser's settings. Below, we present the information on cookie management provided by the following producers of internet browsers:

- 7.7. Should any of the above-mentioned links fail to work, e.g. the browser's producer has moved the information about cookies to another subsite, you can always use the search engine in order to find relevant information, e.g. by entering "Safari cookie clearing".
- **7.8.** At the same time, we would like to inform you that if you use limitations on placing cookie files, it may affect certain functionalities available on the Website.

8. Analytical tools

- **8.1.** Our Website uses a few types of analytical tools, i.e.: Google Analytics, SalesManago and Facebook Analytics, which are used for analysing internet services. These tools use cookie files which have been saved on your computer and allow analysing the way in which you use the Website. The information concerning the way in which you use the Website obtained by cookie files is usually transferred to Google / Facebook / SalesManago servers and stored there.
- **8.2.** You can prevent cookie files from being saved by means of relevant settings in the browser's software (cf. the links provided above). We would like to point out, however, that in such a case you will not be able to take full advantage of Website's all functions.
- **8.3.** Thanks to the statistics obtained, we can improve our offer and make it more interesting to you. The legal basis for using the analytical tools is Article 6 (1) point (f) GDPR, where the legitimate interest is direct marketing.
